4. **Time and date for opening of Bids.** 25 Sep 25 at 1000 Hrs. If due to any exigency, the due date for opening of the Bids is declared a closed holiday, the Bids will be opened on the next working day at the same time or on any other day/time, as intimated by the Buyer.
5. **Place of opening the Bids.** Bids will be opened manually.
6. **Validity of Bids.** The Bids should remain valid for 120 days from the last date of submission of the Bids.
7. **Finalizing of L-1 Firm.** The L-1 firm will be decided based on total amount including GST.
8. **Delivery Period.** Delivery period for supply of items/completion of work would be 90 days from the effective date of contract. Please note that contract can be cancelled unilaterally by the buyer in case items are not received within the contracted delivery period. Extension of contracted delivery period will be the sole discretion of the buyer.
